

BREAKDOWN OF SERVICES

OPTION 1 – LIST HOME TO RENT ONLY

FEE: Equal to one month's rent

- 1. Enter into MLS
- 2. Place a sign and lockbox at the property
- 3. Post the listing to Craigslist, Zillow, Trulia and many other websites
- 4. Show the property to potential prospects (up to 10 showings, \$20 per showing thereafter).
- 5. Provide a rental application and screen the credit for potential applicants and give you a recommendation as to approve or not approve your decision
- 6. If approved, we would write the lease and get it signed by each party.

OPTION 2 – LIST, LEASE AND MANAGE HOME

FEE: Initial Lease Fee equal to one-month's rent and 10% of gross monthly rent *

- 1. All of the above and the following:
- 2. Seek a rental rate that is acceptable to Owner, while considering market conditions
- 3. Make the decision as to the qualifications of the tenant.
- 4. Do a walk through inspection with the tenant and note any items that are not in excellent condition and document with pictures and written report.
- 5. Provide keys to the tenant and give him utility information
- 6. Collect rent and deposit and hold the deposit in our escrow account
- 7. Pay the mortgage, HOA dues and send you the balance in a monthly distribution
- 8. Set up ACH payments for the tenant and landlords for transferring to accounts
- 9. Handle all maintenance issues
- 10. Arrange to have the HVAC serviced twice a year
- 11. Perform inspections of the property and are proactive as to maintenance issues
- 12. Send monthly and yearly statements and issues W-9's at the end of the year
- 13. Oversee repair reserve and contact the Owner for approval if repair exceeds limit
- 14. Deal directly with the tenant for all issues.
